

Acceptable Use Terms for The Team App

These Acceptable Use Terms ("Terms") govern your use of **The Team App** mobile application ("App") and any related services provided by **International Drinking Team** ("Company," "we," "us," or "our"). By downloading, installing, or using The Team App, you agree to comply with these Terms.

1. Purpose of The Team App

The Team App is designed to connect users to events, locations, and social gatherings related to the International Drinking Team. The App helps users discover nearby events, interact with other team members, and access event-related information.

2. Acceptable Use

You agree to use The Team App solely for lawful, personal, and non-commercial purposes. By using the App, you agree not to:

- **Violate any laws:** You must comply with all applicable laws, rules, and regulations in your jurisdiction while using the App.
- **Harass or harm others:** You must not use the App to harass, abuse, or threaten others, or engage in behavior that disrupts other users' experience.
- **Misuse location data:** You must not use the App to gather, share, or distribute false or misleading location data, or violate the privacy of others by tracking their locations without permission.
- **Engage in illegal or harmful activities:** You must not use the App for illegal or fraudulent activities, including but not limited to identity theft, spamming, or phishing.
- **Circumvent security measures:** You must not attempt to reverse-engineer, decompile, or hack The Team App, or interfere with its functioning.

3. User Content

Any content you submit, upload, or share through the App, such as photos, event reviews, messages, or posts ("User Content"), must not:

- **Infringe intellectual property:** You must not submit content that violates copyright, trademark, or other intellectual property rights of third parties.
- **Be offensive or inappropriate:** You must not submit content that is obscene, offensive, or otherwise violates the rights of others.
- **Contain harmful code:** You must not upload or share viruses, malware, or other harmful content.

By submitting User Content, you grant the Company a non-exclusive, royalty-free, worldwide license to use, display, and distribute such content in connection with the operation of The Team App.

4. Privacy and Data Collection

The App may collect personal data, including location information, as described in our Privacy Policy located on www.internationaldrinkingteam.com . By using the App, you consent to the collection and use of your data in accordance with the Privacy Policy.

- **Location Services:** The Team App uses location services to provide users with event recommendations and social interaction based on proximity. You may disable location tracking via your device settings, though this may limit certain features.
- **Data Security:** We implement reasonable security measures to protect your data, but we cannot guarantee absolute security.

5. Restrictions on Use

You must not:

- **Engage in harmful activities:** You may not use The Team App in ways that could damage, disable, or impair the App or interfere with other users' experience.
- **Automated data collection:** You may not use automated tools (e.g., bots, scrapers) to collect data from The Team App without permission.
- **Violation of platform policies:** You must comply with the Google Play Store and Apple App Store guidelines, and you may not use the App in any way that violates these platform policies.

6. Account Responsibility

If the App requires you to create an account, you are responsible for maintaining the confidentiality of your account details and ensuring the accuracy of any information you provide. You must notify us immediately if you suspect unauthorized access to your account.

7. Termination of Access

We reserve the right to suspend or terminate your access to The Team App if we believe you have violated these Terms or engaged in activities that disrupt the functioning of the App. Termination does not affect any rights or obligations that may have accrued prior to termination.

8. Third-Party Services

The Team App may contain links to third-party services or integrate with third-party APIs (e.g., maps, social media). We are not responsible for the content, privacy policies, or practices of these third parties.

9. Limitation of Liability

To the fullest extent permitted by law, **International Drinking Team** shall not be liable for any direct, indirect, incidental, special, or consequential damages resulting from your use of the App, or your inability to use the App. This includes, but is not limited to, any loss of data, personal injury, or damage to property.

10. Indemnification

You agree to indemnify, defend, and hold harmless **International Drinking Team** and its affiliates, directors, employees, and agents from any claims, damages, losses, or expenses (including legal fees) arising from your use of The Team App, your violation of these Terms, or your infringement of any third-party rights.

11. Amendments

We may revise or update these Terms at any time. Any changes will be effective immediately upon posting within the App or on our website. Your continued use of The Team App after changes are made constitutes your acceptance of the revised Terms.

12. Governing Law

These Terms are governed by and construed in accordance with the laws of Washington State. Any disputes arising from these Terms will be resolved in the courts located in Washington State.
